### **General Program Requirements (Form GPRF-21)**

Public Law 22-64

1. Applicant must be a U.S. citizen, a permanent resident alien or who has been a resident of Guam for the immediately preceding five (5) years or a corporation or partnership licensed to do business in Guam.
2. Applicant must be at least 18 years old.
3. Applicant must submit a (1) valid authorization letter from Chamorro Land Trust Commission (CLTC), (2) OR applicant's proof of ownership [Title, Deed], (3) OR a **NOTARIZED** letter stating a landowner's agreement with applicant to farm on the property (Including the names and contact information of both parties; the size, location, lot number, and crop activity of the farmland).
4. Area must be cleared and properly managed **PRIOR TO FARM INSPECTION** and on a continuing basis.
5. Applicant must be willing to comply with Guam Department of Agriculture instruction or recommendations relative to improving his/her farming.
6. The applicant agrees to report to the Guam Department of Agriculture within six (6) months and every six (6) months thereafter.

### **Agriculture Water Rate Program Requirements**

Public Law 9-042

1. Applicant has met at least one (1) of the following farmland activities prior to his farm inspection:
  - a. AQUACULTURE : 50' X 50' size pond or larger;
  - b. CROPS: Vegetable growing comprising of a minimum of half (1/2) acre of one or more crops;
  - c. CROPS: Bean sprouts/Micro-greens production;
  - d. FRUIT TREES: At least fifty (50) fruit trees with a minimum of twenty-five (25) fruit trees of one kind;
  - e. FRUIT TREES: Fifty (50) young betel nut/coconut trees;
  - f. FRUIT TREES: Two hundred (200) banana trees which are properly managed or commercially grown;
  - g. HYDROPONICS: Hydroponic production;
  - h. LIVESTOCK: Minimum six (6) sows or (6) gilts, which are confined in a fence, made of concrete, wooden or a combination of other materials. Fifteen (15) heads on open piggery;
  - i. LIVESTOCK: At least fifteen (15) goats, which are confined;
  - j. LIVESTOCK: At least ten (10) cows;
  - k. LIVESTOCK: At least one hundred (100) chicken layers or other poultry, which are confined in cages. **Game fowls are excluded;**
  - l. NURSERY: Nursery comprising of three hundred (300) or more various sizes of potted plants, which are properly managed;
  - m. TURF GRASS: Turf grass area of at least one (1) acre.

## **Bona Fide Farmer Program Requirements**

Public Law 22-64

1. Applicant must keep financial records of farmland production and marketing for information or statistical purposes of the Guam Department of Agriculture (i.e., farm sales receipts)
